# WSCA Futurity Rules

## Payment Schedule

### 1<sup>st</sup> Payment:

July 1-6      After July 6  
\$50 per class    \$70 per class

### 2nd Payment:

Aug 1-6      Aug 7-15  
\$50 per class    \$70 per class

**NOTE:** Any entries received **AFTER Aug. 15** will have to pay double (\$200)!!

**\*\*The day of show there will be a Office Fee of \$10 per Horse due \*\***

- Entries made after Aug. 15 or on the day of the Futurity will be doubled (\$200)
- No numbers will be given out until all Payments, Office Fees, & Stalls are paid in full.
- **A Stall MUST be purchased and form MUST accompany entry.**
- In the case of an "NSF" check, Futurity winnings will NOT be paid until the check is satisfied. If no Futurity winnings were earned, check will be handled in accordance to WSCA rules.
- NO REFUNDS except in the case of "Death of the Horse". A Vets Certificate is required.

**A Copy of Registration Papers or a Vet Certificate verifying the age of the horse & a copy of a Negative Coggins test MUST be on file before entry is made eligible.**

**WSCA RULES APPLY FOR ALL CLASSES.** Check WSCA Rulebook for legal bits & equipment.

**LUNGE LINE RULES:** Will be in accordance to NSBA rules. When horse enters the arena, they will be judged on conformation. You will have 90 seconds to lunge your horse at a walk, trot & canter/lope. The horse must work both directions without the use of a chain. Handler may carry a lunge whip. Horse will be judged on movement & manners. Can be shown Western or English.

**ALL OWNERS & EXHIBITORS MUST BE MEMBERS OF A WSCA CLUB.** Both must be a member in good standings by May 31.

## **JUDGES & FUTURITY SHOW COMMITTEE RESERVE THE RIGHT TO CHECK BITS.**

1. **Futurity Barrels:** Open to horses 5 years old and younger that have not competed in a barrel competition prior to Jan. 1 of Futurity year. (Including Open Shows, Breed Shows, Rodeos, NBHA Competitions, Futurities & Fun shows). Exhibition runs are allowed (time only).
2. **Derby Barrels:** Open to any horses 6 years old or younger, regardless if the horse was shown in the Futurity or not. These horses are not eligible for the Futurity Barrel class and have **not entered the Derby in a previous year.**
3. **Futurity Pole Weaving:** Open to horses 5 years old and younger that have not competed in a pole competition prior to Jan. 1 of Futurity year. (Including Open Shows, Breed Shows, Rodeos, NBHA Competitions, Futurities & Fun shows). Exhibition runs are allowed (time only).
4. **Derby Pole Weaving:** Open to any horses 6 years old or younger, regardless if the horse was shown in the Futurity or not. These horses are not eligible for the Futurity Poles class and have **not entered the Derby in a previous year**

**\*Pattern must be completed.** A 5 second penalty for each tipped barrel or pole will be given. Judges decision if pattern was completed without being broken. A WSCA Judge will be present during the Game Futurity.
